BRO'S RIDER FOR HIRE TERMS AND CONDITIONS

By availing of the RIDER FOR HIRE SERVICE of BRO'S DELIVERY AND TRACKING (BROS), I hereby understand and agree to the following terms and conditions:

1. BROS will assign a rider to me to assist me in my delivery needs. The rider assigned will be under my supervision from his time-in until his time-out. The time-in and time-out shall be recorded in rider's logbook, and shall be the basis for the charge.
2. The rider shall perform his task for a minimum of eight (8) hours exclusive of one (1) hour lunch break. Should I decide to discharge the rider before completing the first eight (8) hours, the daily rate shall still apply. A fraction of 15 minutes shall be considered an hour overtime.
3. In case, I availed of the rider for hire service on a holiday or Sunday, the appropriate premium rates will apply.
4. I shall be in charge with the route assignment of the rider, which shall be given at the beginning of his work day. Route assignment should be of reasonable distance. The rider shall have the right to refuse the said delivery in case the distance of the delivery is too far or unreasonable.
5. BROS and its rider shall be free from any liability for the damage or loss of the package/item/food to be delivered by the assigned rider in case of fortuitous event, accidents and/or causes not attributed to the rider. Provided, I may claim damages against BROS in the following cases:
 - a. Negligence or recklessness of the assigned rider;
 - b. Intentional failure of the rider to remit or return items/cash/package due to me;
 - c. Damage or loss was due to the driver's lack of skill.
6. In case I desire to claim damages to BROS due to damage or loss of the package/item/food, a written notice must be given within five (5) days otherwise, I shall lose the right to claim thereof.
7. For businesses engaged in food delivery where the rider is required to return to my place of business every after delivery, the delivery distance shall be limited to five (5) kilometer radius.
8. I will not instruct the rider to deliver any objects, articles prohibited by Philippine laws, nor will I engaged BRO'S riders without BRO'S consent even if the rider is no longer connect with the latter.
9. The maximum gas allowance per day shall be ONE HUNDRED FIFTY PESOS (PHP 150.00) only. Should the rider be instructed to deliver items of far distance which will require him to gas up more than the maximum gas allowance shall be shouldered by me. Also, in case there are parking fees, it shall be shouldered by me.

I have read and understood the terms and conditions above-stated and I hereby agree to the same.
